### Holiday Candy Cane Lane Rules & Regulations

- a. NO ENTRY IS PERMITTED TO INCLUDE A LIVE SANTA CLAUS
- b. ABSOLUTELY nothing is to be thrown from the entries due to the numerous safety factors for both participants and spectators. If you would like to include a goody for the spectators, it can be included in the goody bag for the kids that will be given at the end of Candy Cane Lane.
- c. All exhibits for each entry MUST have a minimum of one 2A10BC-type fire extinguisher (Fire Department requirement).
- d. All entries are subject to inspection by the Flagstaff Fire and/or police departments. Entries deemed unsafe cannot participate.
- e. All animal exhibits MUST provide their own pooper scooper and pick up after all animals. Please keep in mind that the weather could be harsh. If you do have an animal in your entry, please make sure to include this in your application.
- f. Please have all participants dress appropriately for the cool temperatures.
- g. Staging begins at 4:30PM sharp and the drive thru gate will open promptly at 5:30PM.
- h. Only vehicles that are part of the exhibit entry may park in the staging area during the time of set up, once set up is complete, all vehicles must be moved to designated parking areas by 5:00PM.
- i. Quiet generators/compressors may be used. Power source will be provided by Shadows Foundation. If needed. (110 Volt outlet). You must have your own extension cord (NO LESS than 100ft long) and power strip if using power provided by Shadows Foundation.
- j. Entry decorations MAY follow religious, holiday, or seasonal themes.
- k. All entry material must be flame retardant
- I. All entries MUST have some form of lighting to give the best light show to our spectators.
- m. All connections must be made with U.L. approved electrical boxes or devices.

- n. In case of extremely inclement weather, the Holiday Candy Cane Lane could be cancelled or rescheduled. A telephone call to the contact person listed on your entry application will be made on December 1st if extreme weather conditions prohibit moving on with the event. That person is responsible for informing all others associated with that entry.
- o. The contact person for parade entry is responsible for letting all participants know the rules
